**Program Overview:**

RICS APC candidates under Graduate Route 1 and 2 are required to complete a period of structured training to meet competency requirements under the guidance of a supervisor and a counselor. The supervisor shall be appointed at the work place and will normally be the APC candidate's manager who is supposed to provide daily work guidance. Counselor must be a chartered surveyor but does not have to be appointed at the place of work.

Many APC candidates in Malaysia who hold a Construction Management / Building Surveying university degree have difficulty in finding qualified supervisors in their workplace. To assist candidates to fulfill the requirements of structured training, RICS Malaysia is inviting RICS professional members (ie MRICS/FRICS) to become a Counselor and supervisor to participate in a Briefing Session on "Adaption for Structured Training for APC Candidates" programme as a counselor/supervisor.
